#### V. PARENT/TEACHER COMMENTS/CONCERNS:

• Parent (Mr. Diaz) asked about the possibility of having an "Investment Account" for some of our H&SA funds. This is to look at the possibility of gaining "interest" in our

- account. Question: Do we have any parents/guardians who have "financial advisor" experience? We will look at this possibility.
- For our "Field Day", which will be held Thursday, May 25<sup>th</sup>, we could use lots of parental help and suggestions to make this year's events a great and fun event for all. - School Safety protocols were brought up by Mrs. Kordos. Exterior doors, which are in the north part of our main building, were discussed. Mr. G did mention "quotes" to replace the remaining 4 doors, again in the north part of our building, is in the process. This would complete the replacements of exterior doors throughout STFCCS, including our Preschool. Mr. G also let parents know that our school has an "interactive" radio that is connected to all law enforcement agencies in our area, including: Alamogordo Police Dept., Otero Sheriff's Office, NM State Police, and the US Border Patrol. This is case we have an emergency and/or crisis. Of course, we ALL PRAY TO GOD this will never be necessary.
- The 2023-24 STFCCS School Calendar was discussed. We are still waiting for our local public school district to provide us their calendar, as we do our best to follow and/or mimic their calendar. This is for possible STFCCS siblings who attend public schools. Mr. G also discussed the NM Legislature "mandating" increased student contact instructional hours for public schools ONLY beginning this coming school year. How does this affect our school? At this point, it does not. Discussion about "year-round" schooling at STFCCS was briefly discussed, as well. Lots of parental and staff input would be necessary to look at this possibility in the future. Mr. G will get the 2023/24 SY Calendar out ASAP, once more information is obtained.
